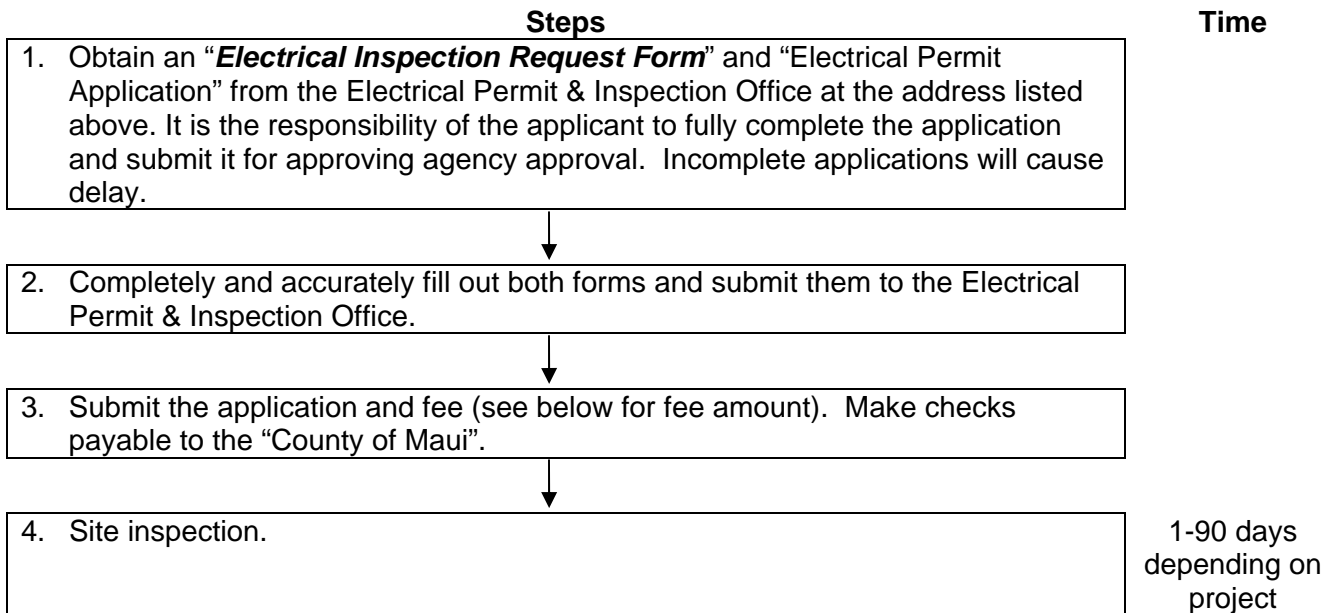

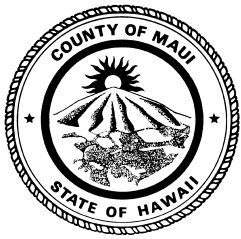
**NOTE:**

- Electrical Permits are generally issued only to State of Hawaii Licensed Electrical Contractors for work within the scope of their license classifications.
- Filing out the necessary forms completely and accurately is important to avoid delay.



**Total Time Period: 1-90 days**

Fees	Amount	Maximum
Fees are dependent on construction phases, amperage and equipment: See Appendix B. Examples Permit Issuance: Service Installation for required size of service equipment for single-phase construction, not over 100 amperes:	\$20	
Public hearing not required.	\$15	
Total Fees:	\$35 (minimum)	No maximum
