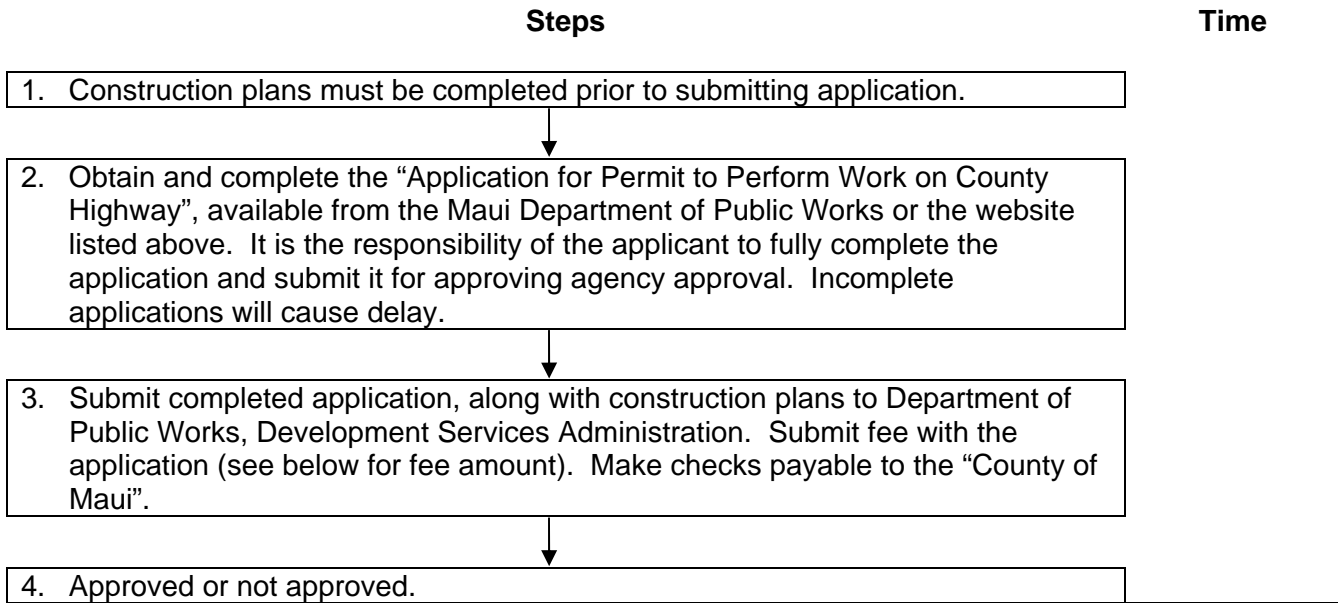

2. The permittee shall notify DSA at least two (2) days prior to commencing work by calling 270-7366.
3. Work shall only occur at the locations specified within this permit and at no other place in conformity with the statutes, ordinances, specification and directions of the Director or Public Works or his authorized representative.
4. Inconsideration of a permit being issued to the applicant, the applicant hereby agrees as follows:
 - a. To undertake for a period of one (1) year after the satisfactory completion of such work, any necessary repairs to highway facilities disturbed and/or caused by the work performed under said permit.
 - b. To protect, defend, indemnify and save harmless, the County of Maui and its agents and representatives, against any claim, liability, suit or action of every manner and description, for any injury to or death of persons or for property damage, whenever such injury, death or damage shall be inflicted or caused by him, his agents, contractors or representatives in connection with the work covered by said permit.
 - c. To perform all construction work according to the applicable sections of the latest version of the Hawaii Standard Specifications for Road and Bridge Construction
5. Applicant shall comply with the latest version of the "Construction Notes Within County Right-of-Way" on file with the department.

THE APPLICANT HEREBY FURTHER AGREES THAT ALL AGREEMENTS HEREIN SHALL BE BINDING UPON HIM, HIS HEIRS, EXECUTORS, ADMINISTRATORS, SUCCESSORS, CONTRACTORS AND ASSIGNS.
