NOTE:

- There may be protests to a change in zoning permit application.
- Applicant may need to acquire the services of a planning, professional engineering and/or surveying firm in order to appropriately complete the required documents for this permit.
- A change in zoning may need to be enacted through ordinance and therefore requires final action by the County Council. There is no timeline estimate for City Council action.

Steps Time

- 1. Obtain and complete the "Change in Zoning Permit Application Packet". It is the responsibility of the applicant to fully complete the application. The accepting agency may or may not inform the applicant of whether the application is complete. Incomplete applications will cause delay.
- 2. Prepare a "Notice of Filing of Application" and a legible location map. Mail to all owners and recorded lessees within 500 feet of the subject property boundaries. Verify this mailing list with the Real Property Tax Records of the County of Maui (Department of Finance, Real Property Division). Submit the Notice, location map, and the "Notarized Affidavit of Mailing of Notice of Application".
- 3. Submit the application and fee (see below for fee amount). Make checks payable to the "County of Maui, Director of Finance".
- 4. After acceptance and agency review, Department of Planning schedules a hearing with the appropriate Planning Commission (Maui, Lanai, or Molokai).
- Applicant must perform the required hearing notice and publication duties set out in the "Application Requiring Public Hearings". Submit the certified mail receipts, certified copy of published notice, and Attachment E to the director.

A Change in Zoning request is to provide a means to establish zoning or to change an established use zone district on a parcel of land to another established use zone district. A Change in Zoning may be granted by County Council provide all the following criteria are met:

- 1. The proposed request meets the intent of the General Plan and the objectives and policies of the community plan of the County;
- 2. The proposed request is consistent with the applicable community plan land use map of the County;
- 3. The prosed request meets the intent and purpose of the district being requested;
- 4. The application, if granted, would not adversely affect or interfere with public or private schools, parks, playgrounds, water systems, sewage and solid waste disposal, drainage, roadway and transportation systems, or other public requirements, conveniences and improvements.
- 5. The application, if granted, would not adversely impact the social, cultural, economic, environmental and ecological character and quality of the surrounding area; and
- 6. If the Change in Zoning application involves the establishment of an agricultural district with a minimum lot size of two acres, an agricultural feasibility study shall be required and reviewed by the Department of Agriculture and the U. S. Soil Conservation Service.

Pursuant to Maui County Code, Section 19.510.040.B Protests:

"B. Protests. Protests may be filed with the appropriate planning commission prior to or on the public hearing date of the application being protested. In the case in which the owners or lessees of forty percent or more of the land located within a five-hundred-foot distance from the boundaries of the subject parcel have filed written protests, the ordinance which grants the application shall not become effective unless approved by a vote

of seven members of the County Council."

GENERAL PROCEDURES

Prior to submittal of an application, a Notice of Filing Application (form provided by the Department of Planning) with a location map will be mailed to all owners and recorded lessees within 500 feet of the subject property boundaries. A copy of the Notice, Location Map and Affidavit of Mailing shall be submitted with the application.

Upon submittal of an application to the Department of Planning, it will be transmitted to the Central Coordinating Agency (CCA) for review for completeness. The CCA fo the County of Maui is the Department of Public Works and Environmental Management, Development Services Administration (DSA).

Upon certification by the CCA that the application is ready for processing, the application will be transmitted to the Department of Planning. The application will be transmitted to the reviewing agencies provided the information submitted in the application is adequate and additional information is not required. The application will be scheduled with the appropriate planning commission for review and action upon receipt of all agency comments.

APPLICATION REQUIRING PUBIC HEARINGS

The following applications are subject to these additional requirements:

- 1. Change in Zoning;
- 2. County Special Use Permits; and
- 3. Project Master Plan.

Upon notification by the Department of Planning of the County of Maui of the scheduled hearing date, the applicant shall:

- 1. Mail a notice of the date of the public hearing of the application on a form provided by the Department of Planning (Attachment D):
 - a. Maui Planning Commission
 - I. Form 1 (CIZ)
 - II. Form 2 (CUP/PMP)
 - b. Molokai Planning Commission
 - I. Form 3 (CIZ)
 - II. Form 4 (CUP/PMP)

By certified or registered mail, return receipt requested, to each of the owners and lessees within 500 feet of the subject parcel, not less than THIRTY(30) calendar days prior to the date of the public hearing;

- Submit the certified mail receipts and each of the return receipts to the Director of Planning not less than TEN (10) business days prior to the date of the public hearing. A Notarized Affidavit of Mailing of Notice of Public Hearing (Attachment E) shall also be submitted as proof of mailing; and
- 3. Publish the subject matter in a form prescribed by the Director of Planning, once a week for three consecutive weeks prior to the date of the public hearing in a newspaper which is printed and issued at least twice weekly in the County and which is generally circulated throughout the County. A certified copy of the published notice shall be submitted to the Director of Planning at least SIX (6) days prior to the date of the public hearing.

Please note that applications requiring final action by the County Council shall be transmitted to the County Council upon completion of all necessary documents (i.e., ordinances, maps, unilateral agreements). The applicant may be required to prepare such documents as amendments to the land use maps and preparation of unilateral agreements. Upon approval of all legal documents by the Department of the Corporation Counsel, the application will be transmitted to the County Council.
